BUSINESS LICENCE REGULATIONS, 2010

The Minister, in exercise of the powers conferred by section 30 of the Business Licence Act, 2010, makes the following regulations —

Citation and commencement.

- These Regulations may be cited as the Business Licence Regulations, 2010.
- (2) These Regulations shall come into force on the 1st day of January, 2011.

2. Interpretation.

In these Regulations -

"Act" means the Business Licence Act, 2010.

3. Forms of application and licence.

- Every application for a business licence under the Act shall be made in Form A as set out in the First Schedule.
- (2) A business licence granted pursuant to section 4 of the Act shall be issued in Form C as set out in the First Schedule.
- (3) An application for an appeal to the Review Board under section 12 of the Act shall be made in Form B as set out in the First Schedule.

Fees.

Fees chargeable in the administration of the Act shall be payable as set out in the Second Schedule.

5. Furnishing of certified statement of turnover.

Where a business has a turnover of one million dollars per annum or more, submitted financial results shall be accompanied by a statement as to the turnover of the business certified by a person who is qualified in accounting and who has no interest in the business to which the certificate relates.
